

## Miss K Bar C Ranch Pageant Handbook & Contract

Being selected to represent the K Bar C Ranch is a privilege and responsibility. The image of a rodeo queen is that of a wholesome, all-american, single cowgirl. Any and all representations of Miss K Bar C Ranch including, but not limited to appearances, photographs, videos, both personal and official social media postings shall exemplify that image at all times.

The Titleholder agrees to comply with the following,

1. To arrive at a minimum of one hour prior to the start of the performance at all scheduled appearances and remain present and engaged for the entirety of the event.
2. To be responsible for reliable transportation to and from all scheduled appearances.
3. If she currently attends school or university, Titleholder is expected to remain in good standing with said institute throughout the entirety of her reign.
4. To provide her own horse for all scheduled appearances
5. Titleholder will not travel to or from any event with anyone other than an approved chaperone.
6. Titleholder will abide by proper phone etiquette at all events. She will not make calls or texts unless it is an emergency.
7. Titleholder will treat all production staff, competitors and spectators with the utmost respect at all times.
8. It is the Titleholder's responsibility to ensure her friends, family and supporters are aware of her commitment and that they do not interfere with her ability to perform her duties.

9. Titleholder will assist with and be present for the entire duration of the following events including but not limited to: The Annual Miss K/C Ranch Pageant, The Curry Classic, the Miss K/C Ranch Rodeo Queen Clinic, the annual K/C Jackpot Series, and any other production or event hosted by or at K/C Ranch.
  - a. Titleholder must be present unless otherwise approved by the chairperson with reasonable notice of a minimum of two weeks prior.
10. Titleholder understands she is NOT promised or expected to receive any compensation during her reign.
11. Titleholder shall not consume illegal drugs or abuse any substance during her reign. She shall only take prescription medication as prescribed that has been prescribed to her.
  - a. Titleholder shall not under any circumstances smoke, vape or use nicotine products in crown and sash.
12. Titleholder shall promptly notify Director/Chairman of any illness or hospitalizations during her reign that will affect her abilities to perform her duties.
13. Titleholder shall arrive at every appearance and function in full regalia (felt hat, crown, banner, and western apparel with hair, makeup and nails neat and presentable).
14. Titleholder shall maintain a wholesome image at all times. This includes wearing proper undergarments, no visible bra straps or pantyline, no visible tattoos or facial piercings. If any outfit is questionable, the final decision shall be left to the Director/Chairperson.
15. Titleholder shall maintain an appropriate, wholesome appearance on all social media accounts and platforms including both the official Miss K Bar C Ranch accounts as well as her own personal accounts.
16. Titleholder shall maintain all official Miss K Bar C Ranch social media accounts during her reign. She shall post regularly promoting the program, scheduled appearances, personal platform and the K Bar C Ranch as well as its sponsors and affiliates. She shall not promote any business, association or personal interest that has not been approved.
  - a. The Director/Chairperson reserves the right to preapprove, remove or edit any posts at their own discretion.

17. No males other than approved immediate family members shall accompany the titleholder going to, from or during the duration of an event she is attending as Miss K Bar C Ranch.
18. Titleholder will not allow herself to be photographed in any way during her year that would imply she is in a dating relationship.
19. Titleholder may have a boyfriend during her year, however she shall not enter into or maintain a public dating relationship during her reign. There will be no public announcements of an engagement, no taking or posting of photographs with her significant other, and no public displays of affection with her significant other.
20. Titleholder is responsible for maintaining the quality of all perpetual items including the Miss K Bar C Ranch Crown, each Miss K Bar C Ranch sash, the Miss K Bar C Ranch perpetual chaps and any other perpetual items she receives during her reign. Blatant lack of care may result in Titleholder reimbursing K Bar C Ranch for the value of said item.
21. Titleholder may order her own personal pair of chaps during her reign that are reflective of her current title if she wishes. Titleholder understands that she is solely responsible for the cost and that the chairperson reserves the right to approve/not approve the design.
22. When making appearances, Titleholder will promote the K Bar C Ranch and all of its offerings. She shall not promote any personal business, personal interest, personal hobby or any other such entities.
23. Titleholder shall treat all employees and affiliates of K Bar C Ranch with the utmost respect at all times and be timely in returning text messages, calls and emails.
24. Titleholder shall maintain her reign for one year from time of coronation until the following pageant and crowning of the next Titleholder.
  - a. Under rare unique circumstances including, but not limited to a lack of contestants for the following year, Titleholder may be offered the opportunity to extend her reign for an additional year. Titleholder must be in excellent standing with the K Bar C Ranch and all of its affiliates in order to be eligible. The decision

to extend a Titleholder's reign shall ultimately be that of the  
Director/Chairperson.

25. Titleholder understands she is strongly encouraged to take the title of Miss K Bar C Ranch to the Miss Rodeo USA pageant held in conjunction with the IFR.

- a. If Titleholder is unable to participate in the MRUSA competition, she understands she is expected to make every effort to attend as visiting royalty and promote the K Bar C Ranch and all of its offerings.
- b. Titleholder understand that regardless of whether she meets the age requirements at time of entry, she shall not compete at the annual Miss Teen Rodeo USA Pageant as Miss K Bar C Ranch. Only Miss Teen K Bar C Ranch may compete for the title of Miss Teen Rodeo USA.
- c. Titleholder understand that she is responsible for the cost of competing at Miss Rodeo USA as well as fundraising efforts throughout the year to offset said cost.

26. Titleholder understands failure to abide by any of the above listed rules and expectations may result in disciplinary action which depending on the severity of or number of offenses could result in termination of her reign.

- a. Titleholder will relinquish the Miss K Bar C Ranch crown, title and all awards if termination occurs.
- b. In the event that a titleholders reign is terminated, the title of Miss K Bar C Ranch will be offered to the first runner up of the pageant.
